Mayor Mabry and the board thanked the donor for their generosity.

Monthly reports were submitted. Street Supervisor Peery was asked about the new mowing crew. Mr. Peery stated he was pleased with their work and was having no issues.

## FIRE DEPARTMENT

Monthly status reports submitted. Doug Tyler stated that the main truck was down but repairs were underway.

### ATTORNEY BILL

A motion was made by Alderman Wolf to approve the monthly attorney bill in the amount of \$2,850 and was seconded by Alderman Watson. All voted aye and the motion carried.

## **NEW BUSINESS**

## **BZA**

Recorder Roberts addressed the board and stated that a BZA meeting was held in City Hall on a variance request in GreyStone Subdivision. Roberts stated that the BZA granted a 7 foot variance on the front setback on the corner lot of Sand-

stone and Granite Drive. This variance allowed the lot to be usable as a ditch bisects the property. Roberts stated that this was merely an update to the board and a way to memorialize the meeting in the minutes.

#### **GAS CONTRACT**

Recorder Roberts requested permission to enter into a contract with Constellation to purchase natural gas for the City. Roberts stated that our current provider Conoco, had assessed a 12 cent fee on units purchased and the city would save money going with the new provider. Roberts stated that the contract was reviewed by City Attorney Lannom and his recommended changes were included. A motion was made by Alderman Hardin to approve the new contract and was seconded by Alderman Thomas. All voted aye and the motion carried.

#### PROPERTY MAINTENANCE

Mayor Mabry addressed the board and stated that she was not pleased with the current application of the property maintenance ordinance. Mayor Mabry stated she had talked with Chief Barr and they would find a way to administer the ordinance in a healthy manner and keep Newbern looking beautiful.

## LIQUOR LICENSE

Mayor Mabry addressed the board and stated that Sam Patel had made application to move his existing liquor license to a new location in Newbern. Mr. Patel listed 121 and 125 Hwy 77 in Newbern both of which meet the current zoning requirements. After some discussion a motion was made by alderman Lamb to approve the certificate of compliance and was seconded by Alderman Thomas. All voted aye and the motion carried.
