REGULAR MEETING NEWBERN BOARD OF MAYOR AND ALDERMEN MAY 21, 2019

CALL TO ORDER AND APPROVAL OF MINUTES

Mayor Mabry called the meeting to order. Nicky Thomas was asked to say the opening prayer. Mayor Mabry asked if the Board of Mayor and Aldermen had reviewed the minutes from last month's meeting.
