## APPROVAL OF MINUTES

#### **DEPARTMENT REPORTS**

#### FINANCIAL UPDATE

Recorder Roberts presented the monthly financial update.

#### POLICE DEPARTMENT REPORT

Chief Barr requested permission to hire Michael Permenter as a patrolman. A motion was made by Alderman Thomas to approve the hire and was seconded by Alderman Hardin. All voted aye and the motion carried.

#### LIBRARY

Mayor Pam Mabry requested approval for the promotion of Glenda Yarbrough to Assistant Library Director. This request came from the recommendation of the Library Board. A motion was made by Alderman Thomas to approve the promotion and was seconded by Alderman. Lamb. All voted aye and the motion carried.

#### ATTORNEY BILL

A motion was made by Alderman Ware to approve the attorney bill and was seconded by Alderman Watson. All voted aye and the motion carried.

#### **NEW BUSINESS**

## **MOWING BID**

Recorder Roberts addressed the board and stated that the current mowing company had requested to modify their bid for service. Roberts stated that the request would increase the mowing amount \$150.00 per mow. Roberts stated that that the increase was due to a miscalculation of acreage and increase in chemical costs. The increase would still place MowTech substantially below the next closest bidder. Street Supervisor Peery stated that he reviewed the increase and in his opinion the request was valid. A motion was made by Alderman Ware to approve the modification and was seconded by Alderman Hardin. All voted aye and the motion carried.

#### **OAKVIEW POOL**

Recorder Roberts addressed the board concerning the status and history of the pool. The pool was erected in 1969 and served the community well. Unfortunately, the condition has deteriorated to a point that repairs are untenable. Roberts stated that he and Street Supervisor Peery reviewed the costs of operation over the past 6 years. This data showed an average loss of \$51,000.00 per year. Street Supervisor Peery stated that it was his desire to close the pool and erect a Splash Pad in its place. The benefits of the splash pad are increased service times from 8 weeks of pool to 7 months of splash pad, decreased maintenance and operation expense and creating an attraction to our area. After much discussion a motion was made by Alderman Hardin to close the pool this year and seek out costs and designs on a Splash Pad. The motion was seconded by Alderman Lamb. All voted aye and the motion carried.

This program would allow Newbern to achieve membership in the TN Main Street program and open up many new grant opportunities for our town.
