# CALL TO ORDER AND APPROVAL OF MINUTES

Mayor Dennison called the meeting to order at 7:00 pm and asked Alderman Fesmire to open with a prayer. The Board of Mayor and Aldermen reviewed the minutes from the April 17<sup>th</sup> regular meeting and the May 8<sup>th</sup> special meeting. Alderman Robert Hart made a motion to accept the minutes with Alderman Olen Parker second. All voted aye and the motion passed.

# DCHS Girls Volleyball Roadblock

Regina Childers with DCHS Girls Volleyball came before the Board to request approval for a roadblock. Alderman Parker made a motion to suspend with visitor business to discuss the roadblock approval criteria which was on the agenda in old business and the Board so moved. After discussion and approval of roadblock criteria Alderman Clements made a motion to approve Ms. Childers request for a roadblock on August the 4th with Alderman Fesmire second. All voted yea and the motion carried.

### West TN Stixx Roadblock

#### **OLD BUSINESS**

Road Block Approval Criteria

Road block approval criteria was discussed by the board of Mayor and Alderman. The Board members created a policy that outlined the requirements necessary for a group to become eligible to conduct a roadblock. The policy created will be enforced by Police Chief Harold Dunivant and approval will be granted by City Recorder Jason Roberts. The policy will be kept on file in City Hall along with the Disclaimer required and the initial request. Alderman Clements made a motion to accept the roadblock approval criteria with Alderman Fesmire second. All voted yea and the motion passed.

Alderman Elections

Alderman Parks suggested to the Board that the elections for the 6 alderman positions should be split. This split would require elections for three of the six alderman position every two years. The Board decided not to change the current election structure.
