# REGULAR MEETING NEWBERN BOARD OF MAYOR AND ALDERMEN October 16, 2007 7:00 PM

# CALL TO ORDER AND APPROVAL OF MINUTES

Mayor Dennison called the meeting to order at 7:00 pm and asked Alderman Clements to open with a prayer. The Board of Mayor and Aldermen reviewed the minutes from the September 18, 2007 Regular Meeting. Alderman Fesmire made a motion to accept the minutes with Alderman Parks second. All voted aye and the motion passed.

#### **OLD BUSINESS**

### RURAL DEVELOPMENT - HANDICAPACCESSIBILITY

City Recorder Jason Roberts presented the Board of Mayor and Alderman with the revised bids on the Rural Development Handicap Accessibility project. The bids were as follows:

Billy Turnbo - \$10,975.00 Stout Enterprises - \$11,200.00

The revised bids submitted included an automatic door for City Hall and replacement of doorway in the Municipal Building. Alderman Parks made a motion to accept the lowest bid from Billy Turnbo and was seconded by Alderman Fesmire. All voted aye with and the motion carried with Alderman Parker recused.

### **NEW BUSINESS**

### PROPOSED DOG ORDINANCE - 1ST READING

Mayor Dennison addressed the board about the proposed ordinance. Mayor Dennison stated that the proposed ordinance was sent out for inspection and review by the members because of its length. Alderman Parker made a motion to suspend with the reading of proposed ordinance and display the ordinance in City Hall and the Newbern Public Library. The motion was seconded by Alderman Dycus. All voted aye and the motion to suspend the 1st reading passed.

After discussion of the proposed dog ordinance Alderman Parker made a motion to accept the first reading and schedule a public hearing with Alderman Parks second. All voted aye and the motion carried.

# PROPOSED FLOOD ORDINANCE - 1ST READING

Mayor Dennison addressed the board about the proposed flood ordinance and stated that he attended a meeting which covered the flood plan changes. Mayor Dennison stated the proposed ordinance was lengthy and requested a motion to suspend the first reading aloud and display the proposed ordinance. Alderman Fesmire made a motion to dispense with the reading with Alderman Parks second. All voted aye and the motion carried. Mayor Dennison stated that the proposed flood ordinance had limited changes for the City of Newbern and has been reviewed by the Newbern Planning Commission. Alderman Fesmire made a motion to accept the first reading with Alderman Parks second. All voted aye and the motion carried.

#### KIRBY STREET

Mayor Dennison addressed the Board about Kirby Street. Mayor Dennison stated that he had a request that the City of Newbern install a road on what is known as Kirby Street. Kirby Street is labeled on the plat map of Newbern but was never installed. The board discussed this request and did not find it feasible at the present time. Alderman Parker made a motion to pass on installing the road with Alderman Parks second. All voted aye and the motion carried.
