# WASTEWATER PUMP RESOLUTION 12-04

A bid opening was conducted at the Newbern City Hall building for the approval of the purchase of equipment for Wastewater pump upgrades. The lowest and best bidder, Gulf States, was recommended with a bid of \$24,000.00. Gulf States has been used previously and meets all specifications. Recorder Roberts read aloud resolution 12-04 which awarded the contract to Gulf States. A motion was made by Alderman Parks to approve the Resolution and was seconded by Alderman Greene. All voted aye and the motion carried.
